Subject: Mandatory Stop Use Notice – PAPR Cartridges SKUs PA7DEHE and PA7OVAGHE

WARNING! All recipients of this Mandatory Stop Use Notice must read, understand and follow all instructions carefully.

Dear Honeywell Respiratory Protection Customer,

At Honeywell, our mission is to be the global leader in personal protective equipment with innovative solutions that help protect workers and workplaces. Aligned with this commitment, we are contacting you because Honeywell identified a quality issue related to certain Powered Air Purifying Respirator (PAPR) Cartridges that may cause bodily harm to end-users. This quality issue with these parts could cause possible exposure to carbon and other substances, creating a potential safety issue for the user.

Honeywell Personal Protective Equipment has issued a Mandatory Stop Use Notice of the PAPR Cartridges PA7DEHE and PA7OVAGHE produced prior to November 2022.

While Honeywell is not aware of any safety incidents related to this issue, it is issuing a STOP USE notice out of an abundance of caution.

Immediate action is required. These cartridges must not be used and any cartridges in inventory must be placed on quality hold.

Honeywell paused production and corrected the issue affecting the cartridge. Production and Delivery of new cartridges has resumed after updating our process and resolving the quality issue.

REQUIRED ACTIONS:

- Immediately forward this notice to any of your customers/users who have purchased the impacted products produced prior to November 2022 with an urgent request that they read and comply with the notice
- Ensure that your customers forward this safety information to their customers.
- If you still have inventory of the cartridges concerned, immediately stop selling them.
